



PLEASE READ CAREFULLY THIS DOCUMENT. The undersigned, on my own account, expressly stating that I wish to participate in the event denominated **"Half Marathon Rock'n'Roll AT&T Monterrey 2018"**, to be carried out in the city of Mexico, **Saturday, June 16, 2018**. (The EVENT), likewise, I commit myself and I am obligated not to enter into the RESTRICTED AREA(S) (being understood as the area requiring a special authorization, credentials or permits to enter by the organizing committee) by virtue of the foregoing by signing this document I accept all and each of the terms and conditions stipulated herein:

1. It is expressly understood that in order to participate in the EVENT a registration shall be carried out, in accordance with the procedures published to that effect by AS DEPORTE, S.A. DE C.V. on its internet site (www.asdeporte.com) or in any other mean deemed convenient by AS DEPORTE, S.A. DE C.V.
2. Specifically in the case of the event called **"Half Marathon Rock'n'Roll AT&T Monterrey 2018"**, in all its editions, I know the nature of the event, understanding that this is an event of "high risk", for example, dangerous activities as extreme obstacles, including fire, mud trenches, barbed wire, cargo net, junk vehicles, heights, climbing, swimming, jumping into the water, crossing water, crossing hills and / or uneven terrain; including that I know that there may be obstacles for the development of the event, such as rain, moisture or heat; as well as physical capacities and experience with that story, stating that they are suitable to participate in the event, because of the above expressly manifest meet in perfect health, both physically and mentally health to participate in the event and develop all and each of the activities conducted therein; holding me at all times as provided herein expressly represent that I know the nature of the EVENT and the experiences and skills that I have and which are suitable in order to participate in the EVENT, therefore, I expressly represent that I am in perfect health condition, both physically and mentally in order to participate in the EVENT and to perform all and each of the activities thereof. Likewise, I am aware of the EVENT'S development and activities, and therefore in case the Organizing Committee deems that any of them is unsafe or represent any risk for me or for the other participants it may cancel the EVENT without the organizing committee and/or AS DEPORTE, S.A. DE C.V., and its affiliates and subsidiaries and their shareholders, being liable. In case I do not take into consideration the instructions issued by the organizing committee and/or AS DEPORTE, S.A. DE C.V., I expressly assume the consequences derived from my omission to the instructions issued by the organizing committee and/or AS DEPORTE, S.A. DE C.V., releasing the organizing committee and/or AS DEPORTE, S.A. DE C.V., and its affiliates and subsidiaries and their shareholders, from any liabilities.
3. I expressly acknowledge and accept that: a) the activities carried out during the EVENT are my own risk, and the participation therein and/or entrance to the restricted areas, might cause physical injuries to me, including partial or total disability, paralysis and death (collectively the RISKS); b) these RISKS and dangers may be caused due to my own omission, activity or inactivity before, during and after the EVENT, other participants' omission, activity or inactivity in the EVENT, the EVENT'S rules, the conditions and distribution of the establishments and equipment, or negligence of individuals who I release from all liabilities, or due to weather conditions in the city where the EVENT takes place, or the performance itself of the activities in which the EVENT consists; c) there could be other RISKS unknown for me or which are not yet foreseeable or, in case the same are foreseeable I know, I acknowledge and assume, or could derive from acts of God or force majeure; d) the social and economical losses and/or direct or indirect damages which might result from this RISKS, could be severe and permanently modify my future; e) Under no circumstances, reason or cause I can't get off the bracelet or the number of competitors that are given to me at the start of EVENT; f) In the event that some alcoholic beverages (with low alcohol percentage) such as beer, are development after the EVENT, I agree to be provided and acknowledge that I am old enough power to consume a drink of this type, and if I take a drink of this type, is under my own responsibility the effects that they can have on me.
4. I expressly represent that it is my wish to participate in the EVENT, therefore my participation, as well as entering the restricted areas, will be under my own and absolute responsibility and I hereby assume all and each of the RISKS, known or unknown, and I assume all liability derived from my omission, among other, such as total or permanent disability, paralysis or even death, even if the same are in whole or in part caused by the negligence of the persons who I hereby release from all liabilities.
5. I also declares that the objects used during my participation in the event, accessories, and any other that is used by me to participate in the EVENT, are my property, so I have the full capacity to use and exploitation that objects, and I waive all liability in respect thereof to AS DEPORTE, organizers, organizer of the event, their officials and other participants regarding the use, partial loss or total, including but not limited to transition zone, wardrobe or any other area, loss or misplacement of that objects, stating that I am solely responsible for them, so I don't reserve any right or action against any third party for damages could may cause to my property or equipment.
6. I hereby authorize the organizers and/or any person appointed thereby that in case I suffer any accident due to my participation, activity or inactivity before, during and after the EVENT, the necessary medical attention is provided to me, as well as to be transferred to the nearest hospital or to any hospital designated by the organizing committee or AS DEPORTE, S.A. DE C.V., in order to be attended, including to have full access to my medical records, as well as to supply the medication deemed convenient for my health or in case a surgical intervention is carried out to me or the necessary medical procedures making their best efforts to safeguard my health, understanding that the undersigned may reject any medical care needed so that in both cases, in this act, the undersigned, my family, heirs and any other party with an interest in me; exonerating the organizing committee and/or AS DEPORTE, S.A. DE C.V., and its affiliates and subsidiaries and their shareholders, and their respective officers, directors, managers, employees and agents from all liabilities for the actions referred to herein or for the immediate or future consequences which might derive from my participation in the EVENT. i agree to assume full responsibility for any and all medical expenses incurred as a result of medical care that I get to provide, for damages or injury to my person for my participation in the EVENT, including but not limited to ambulance transport, hospital stays, doctors' fees and pharmaceutical goods and services.
7. I hereby, expressly exonerate the organizing committee, AS DEPORTE, S.A. DE C.V., and its affiliates and subsidiaries and their shareholders, and their respective officers, directors, managers, employees and agents from all liabilities and expressly state that I will instruct my relatives or representatives, not to file any legal action, against the organizing committee or AS DEPORTE, S.A. DE C.V., and its affiliates and subsidiaries and their shareholders, and their respective officers, directors, managers, employees, agents, promoters, participants, participants' association, regulatory organizations or any subdivision thereof, operators, owners, officials, rescue personnel, any person located in the restricted area, promoters, sponsors, owners and licensees of the permits directly or indirectly related to perform the EVENT, inspectors or technical delegates, surveyors, insurers, advisors and any other person or entity participating or issuing recommendations, indications or instructions or taking part in the evaluation of the RISKS or activities, loss of control regarding the EVENT and each of them, their directives, shareholders, representatives, employees, actors, official contractors, agents and employees, organizers, affiliates or subsidiaries of the organizers (all of them referred for the purposes of this document, as the exonerated parties) from any liability towards me, my representatives, assignees, heirs, and closest relatives, from any and all claims, legal actions or damages regarding any injury suffered by my, including but not limited to death, or damage to property, caused or supposedly caused, in whole or in part, by the exonerated parties' negligence or in any other form whatsoever.
8. If, derived from the stipulations contained in this release, the undersigned or my family, heirs, successors, or any third party related with me, file a claim against any of the previously mentioned exonerated parties, I agree to indemnify and hold such exonerated parties and each of them harmless from and against any trial, expenses, legal fees, losses, liabilities, damages or costs in which they might incur due to the legal actions against any of the previously mentioned exonerated parties, regardless that such claim is based in the exonerated parties' negligence or in any other manner.
9. I hereby acknowledge and accept that the registration carried out is not reimbursable due to any reason whatsoever, as well as that the same is non-transferable to third parties, therefore, in case the EVENT is cancelled due to any reason, including acts of god or force majeure, also including but not limited to hurricane, tornados, storms or any other which under the organizers of the EVENT'S judgment might put me in danger. Such registration fee shall not be reimbursed and the costs incurred by the undersigned in order to participate in the EVENT shall not be paid. In this case it shall not be deemed that the cancellation of the EVENT is due to the organizers' negligence or to the negligence of the persons that participate in the development thereof; therefore I hereby release the organizing committee and/or AS DEPORTE, S.A. DE C.V., and its affiliates and subsidiaries and their shareholders and the exonerated persons described in item "7" above from any liability in that regard.
10. I acknowledge and accept that as participant in the EVENT, I shall bear at all times the participant number or the certification provided to me by the EVENT organizers, it being understood that such number or certification may not be transferred or exchanged with any third party under no concept; therefore, if I do not have it, the EVENT organizers, may dismiss me thereof, releasing them from all liability, as well as waiving to exercise any legal action against them due to the measures adopted in this regard.
11. I hereby authorize the organizers and/or their designees to use my voice and image, whether in whole or in part, in connection with my participation in the EVENT, in any manner and at any time, expressly waving the collection of any amount which might be produced from the above mentioned uses.
12. I acknowledge and agree that in the development of the EVENT, there will be a "Cold Kitchen" area, where each of the participants may access and taste the food offered on the same, from the above, from this moment, I expressly exonerate the organizing committee or AS SPORT, S.A. de C.V. and its affiliates and subsidiaries and their shareholders, and their respective officers, directors, managers, employees and agents and any person or employee to assist in the organization and development of the EVENT and expressly declare in instructing my family or guardians not to exercise any legal action against the organizing committee or AS SPORT, S.A. de C.V. and its affiliates and subsidiaries and their shareholders, and their respective officers, directors, managers, promoters, participants, associations participating regulatory organizations or any subdivision of these operators, owners, officers, rescue personnel, any personnel who are in the restricted area, promoters , sponsors, advertisers, owners and licensees of the permissions that are directly or indirectly related to the EVENT, inspectors or technical delegates of the event, vigilantes, insurers, consultants and any other person or entity that has an interest or issue recommendations, directions or instructions or taking part in risk assessment or loss control activities regarding the EVENT and every one of them; their directors, shareholders, agents, employees, stakeholders, contractors officers, agents and employees, organizers, affiliates or subsidiaries of the organizers (all referred for the purposes of this document, as released) from all liability to me, my son or daughter, to my representatives, assigns, heirs, and next of kin, for any and all claims, legal actions or damage relating to any damage to my person, including but not limited to death or property damage caused or allegedly caused by ingestion of these foods and any discomfort, allergy, injury or illness that they could cause me or my son or daughter at any time of the EVENT or subsequent tereto.

In case the EVENT presents any relay activity, the undersigned represents to be the captain of the team, expressly stating that he/she is empowered by the other members of the team to sign this document on their name and behalf, being obligated to obtain from each of the members of the relay team the relevant release from liability, and being personally obligated to be liable towards the EVENT organizers and towards the exonerated persons established in item "7" above, as well as to hold them harmless and to release them from and against all liabilities, regarding any action, complaint, accusation, legal action or proceeding filed against them by the members of the relay team mentioned herein.

I acknowledge and agree that in the case that the participant the EVENT is a minor, must read and sign both; the minor and the parent or guardian, the document attached hereto as "Statement to minors" recognizing that if this declaration, is not signed by the minor, the parent or the guardian; the minor should not participate in any activity of the EVENT.
18. I accept and acknowledge that in case any kind of controversy arises in connection with my participation in the EVENT, the same shall be subject to the applicable law and to the jurisdiction of the competent courts in Mexico City, waiving any other jurisdiction which might correspond to me by virtue of my present or future domicile.
19. In case that this waiver be signed by a third party, and if the Participant does not have ID to sign it, the PARTICIPANT expressly authorizes the third party to sign on their behalf and to assume responsibility for the PARTICIPANT in accordance with the provisions herein.
